<u>Discuss and consider action on Site and NPS plan for the Park at Bee Cave located at the northwest corner of RR620 South and SH-71, Bee Cave, Texas.</u>

Mr. Patino reported that the Site plan set meets all requirements of development standards as stated in the applicable sections of PD Ordinance 01-09-11-A. Staff recommended approval subject to the following conditions: submission of approved driveway permit from TXDOT, submission of an updated impervious cover "decrease" plan sheet and submission of an updated lighting plan detail for applicable parking lot light pole pedestals. All of these conditions were met prior to the beginning of the Council meeting.

Brad Walters, Walters Southwest, was present at the meeting.

Danny Miller, LJA Engineering, answered questions about traffic concerns and driveway locations.

The City Council reviewed the allowable uses as stated in Ordinance No. 01-09-11-A and expressed concern about the density of the project and the removal of so many trees.

Mayor Murphy commented that the City of Bee Cave entered into a lawsuit in early 2000 on this property trying to enforce the ordinances that the City had in place. The City lost that lawsuit so this settlement agreement is a result of that lawsuit. The property had a lot of grandfathered rights.
